This Privacy Policy lets you know what personal information of yours we hold, what we do with it, who we will disclose it to and how you can access the personal information we hold about you. You can also find out here how to change inaccurate personal information and how to opt out of receiving communications from us.

How does Agency collect and hold your Personal Information?

Where possible Agency will generally collect your Personal Information directly from you or from what is disclosed to us on social media platforms. We may also collect Personal Information to conduct background checking that may be required as part of the recruitment and selection process.

What Personal Information about you does Agency collect and hold?

Website

When visiting this website the server makes a record of the visit and logs the following information for statistical and administrative purposes:
